This Warranty runs from the date of purchase and warrants that the Manhasset[®] Product is free from defects in material or workmanship during the warranty period as described in the Length of Product Warranties section below. If Manhasset determines, in its sole discretion, that the Product has a defect covered under this Warranty, Manhasset, at its election, shall either repair or replace the defective Product without charge to the original purchaser. **SUCH REMEDY SHALL BE YOUR SOLE AND EXCLUSIVE REMEDY FOR ANY BREACH OF WARRANTY.**

If Manhasset determines that a Product return is necessary, the Customer Service representative will issue a return authorization.
