

These instructions contain important safety information regarding the use and maintenance of this unit. Please keep this manual with the unit, for future reference.

## Warranty Registration

The PinPoint GO WW Plus carries a two year limited warranty. Please fill out the enclosed warranty card to validate your purchase. All returned service items whether under warranty or not, must be freight pre-paid and accompany a return authorization (R.A.) number. The R.A. number must be clearly written on the outside of the return package. A brief description of the problem as well as the R.A. number must also be written down on a piece of paper included in the shipping carton. If the unit is under warranty, you must provide a copy of your proof of purchase invoice. You may obtain a R.A. number by contacting our customer support team on our customer support number. All packages returned to the service department not displaying a R.A. number on the outside of the package will be returned to the shipper.

## PinPoint GO WW Plus

## Cleaning

Due to fog residue, smoke, and dust cleaning the internal and external optical lenses must be carried out periodically to optimize light output.

1. Use normal glass cleaner and a soft cloth to wipe down the outside casing.
2. Clean the external optics with glass cleaner and a soft cloth every 20 days.
3. Always be sure to dry all parts completely before plugging the unit back in.

Cleaning frequency depends on the environment in which the fixture operates (i.e. smoke, fog residue, dust, dew).

- To reduce the risk of electrical shock or fire, do not expose this unit rain or moisture
- Do not spill water or other liquids into or on to your unit.
- Be sure that the local power outlet match that of the required voltage for your unit.
- Do not attempt to operate this unit if the power cord has been frayed or broken. Do not attempt to remove or break off the ground prong from the electrical cord. This prong is used to reduce the risk of electrical shock and fire in case of an internal short.
- Disconnect from main power before making any type of connection.
- Do not remove the cover under any conditions. There are no user serviceable parts inside.
- Never operate this unit when it's cover is removed.
- Never plug this unit in to a dimmer pack
- Always be sure to mount this unit in an area that will allow proper ventilation. Allow about 6" (15cm) between this device and a wall.
- Do not attempt to operate this unit, if it becomes damaged.
- This unit is intended for indoor use only, use of this product outdoors voids all warranties.
- During long periods of non-use, disconnect the unit's main power.
- Always mount this unit in safe and stable matter.
- Power-supply cords should be routed so that they are not likely to be walked on or pinched by items placed upon or against them, paying particular attention to the point they exit from the unit.
- Cleaning -The fixture should be cleaned only as recommended by the manufacturer. See page 3 for cleaning details.
- Heat -The appliance should be situated away from heat sources such as radiators, heat registers, stoves, or other appliances (including amplifiers) that produce heat.
- The fixture should be serviced by qualified service personnel when:
  - A. The power-supply cord or the plug has been damaged.
  - B. Objects have fallen, or liquid has been spilled into the appliance.
  - C. The appliance has been exposed to rain or water.
  - D. The appliance does not appear to operate normally or exhibits a marked change in performance.

## 1. Handling of Batteries

### 1.1 Do Not Short Circuit the Battery

Try to never short circuit the battery. It generates a very high current which could cause the battery to overheat which may result in electrolyte gel leakage, harmful fumes, or explosion. The LIR tabs may easily short-circuit by placing them on conductive surface. A short circuit may lead to heat build up and damage of the battery. An appropriate circuitry with PCM is employed to protect accidental short circuit of the battery pack.

### 1.2 Mechanical shock

Dropping the unit, impact hit, bending, etc. may cause failure or short-end life of the LIR battery.

## 2. Other

### 2.1 Battery connection

- 1). Direct soldering of wire leads or devices to the battery is strictly prohibited.
- 2). Lead tabs with pre-soldered wiring shall be spot welded to the batteries. Direct soldering may cause damage of components, such as separator and insulator, by heat build up.

### 2.2 Prevention of short circuit within a battery pack

There is enough insulation layers between wiring and the batteries to provide extra safety protection. The battery pack is constructed in a way that no short circuit will occur which may cause smoke or fire.

### 2.3 Do No Disassemble the Batteries

- 1). Never disassemble the batteries.  
Doing this may cause a internal short circuit in the battery, which may lead to harmful fumes, fire, explosion, or other problems.

- 2). Electrolyte Gel is harmful  
Electrolyte Gel should not leak from the LIR battery. Should the electrolyte gel come into contact with the skin or eyes, flush the area of contact immediately with fresh water and seek medical attention immediately.

### 2.4 Do Not Expose the Battery to Heat or Fire

Never incinerate or dispose of the batteries in fire. This may cause an explosion, which would be very dangerous.

**2.5 Do Not Expose the Battery to water or liquids**

Never soak/drop the batteries in liquids such as water, seawater, drinks such as soft drinks, juices, coffee or other.

**2.6 Battery Replacement**

For battery replacement please contact ADJ customer support (800) 322-6337.

**2.7 Do Not use a damaged Battery**

The battery could be damaged during shipping, caused by shock. Should the battery be found damaged, including damages to the plastic casing of the battery, deformation of the battery package, smelling of an electrolyte, or leakage of the electrolyte gel, or other, DO NOT use the battery. A battery with a odor of electrolyte or a gel leakage should be placed away from fire to avoid fire or explosion.

**3. Battery Storage**

When storing the battery, it should be stored at room temperature, with a charge of at least 50%. We recommend that during long periods of storage that the battery be charged every 6 months. Doing this will prolong the life of the battery and will also make sure that the battery charge does not fall below the 30% mark.

**4. Other Chemical Reaction**

Because batteries utilize a chemical reaction, battery performance will deteriorate over time even if stored for a long period of time without being used. In addition, if the various usage conditions such as charge, discharge, ambient temperature, etc. are not maintained within the specified ranges, the life expectancy of the battery maybe shortened or the device in which the battery is used may be damaged by electrolyte gel leakage. If the batteries cannot maintain a charge for long periods of time, even when they are charged correctly, this may indicate it is time to change the battery.

**5. Battery Disposal**

Please dispose of battery according to local regulations.

**Energy Saving Mode:**

There are 3 ways you can set the PinPoint GO WW Plus into energy saving mode. When the PinPoint GO WW Plus is set into energy saving mode, it will decrease the LED brightness gradually when the battery life is less than 80% to extend the battery life. **NOTE: When the unit is using DC power, the energy saving mode cannot be used.**

1. Press the MODE button for 5 seconds to switch between normal mode and energy saving mode. When the LED flashes 3 times, the PinPoint GO WW Plus is in normal mode. When the LED flashes for 5 seconds the PinPoint GO WW Plus is in energy saving mode.
2. Using the ADJ UC IR, press the STAND BY button for 5 seconds to switch between normal mode and energy saving mode. When the LED flashes 3 times, the PinPoint GO WW Plus is in normal mode. When the LED flashes for 5 seconds the PinPoint GO WW Plus is in energy saving mode.
3. Using the ADJ LED RC3, press the BLACKOUT button for 5 seconds to switch between normal mode and energy saving mode. When the LED flashes 3 times, the PinPoint GO WW Plus is in normal mode. When the LED flashes for 5 seconds the PinPoint GO WW Plus is in energy saving mode.

**Low Battery Warning:**

When the battery power gets below 30%, the LED will flash rapidly for 5 seconds each time the power is switched ON. After the 5 seconds, the unit will function normally. This is a warning letting you know that you must charge the unit soon.

**Battery Recharge:**

To recharge the battery, plug the supplied DC power supply into the DC input located on the rear of the unit and plug the other end into a matching power supply. It takes about 6.5 hours to reach full charge with the power switch off.

**Operating Power:**

There are two ways to supply power to this unit; battery power or DC power.

- DC Power - To run the unit using DC power, plug the unit into a DC power source, and put the POWER switch into the ON position.

• **Battery Power** - To run the unit using Battery power, put the POWER switch in the ON position.

**Mode Button Lock:**

**The MODE button will lock itself after 30 seconds if nothing is pressed. To unlock the unit, press the MODE button for 3 seconds.**


**Mode Operation:**

Each press of the MODE button will cycle through the different operating modes. The operating modes are listed below in the order that they appear. **NOTE: When power is turned OFF and turned back ON, the unit will start in the last operating mode.**

**Order of Operating Modes:**

- 100% Brightness • 95% Brightness • 90% Brightness
- 84% Brightness • 78% Brightness • 72% Brightness
- 66% Brightness • 60% Brightness • 54% Brightness
- 48% Brightness • 42% Brightness • 36% Brightness
- 30% Brightness • 24% Brightness • 18% Brightness
- 12% Brightness • 6% Brightness • LED Off • Fast Fade • Slow Fade

Pressing the MODE button again after Slow Fade will return the unit to 100% brightness. Starting the operating mode order at the beginning.



The **ADJ LED RC3** infrared remote (Sold Separately) has many different functions and gives you complete control of your PinPoint GO WW Plus. To control the your desired fixture you must aim the controller at the front of the fixture and be no more the 30 feet away.

**BLACKOUT** - Pressing this button will blackout the fixture. This button is also used to switch between normal mode and energy saving mode. When the LED flashes 3 times the unit is running in normal mode. When the LED flashes for 5 seconds the unit is running in energy saving mode. Please see Energy Saving Mode on the previous page.

**AUTO RUN MODE** - Press the AUTO RUN button to switch between Fast Fade & Slow Fade. Press the SPEED button and use the “+” & “-” buttons to adjust the fade speed. You can press the FLASH button to activate strobing and use the “+” & “-” buttons to adjust the strobe speed.

**MANUAL MODE** - Press the SELECT PROG button to activate WW color. Use the “+” & “-” buttons to adjust the output intensity. Press the FLASH button to activate strobing and use the “+” & “-” buttons to adjust the strobe speed.

## PinPoint GO WW Plus

## UC IR/Airstream Control

The **UC IR (sold separately)** infrared remote gives you control of various functions (See below). To control the fixture you must aim the remote at the front of the fixture and be no more than 30 feet away.

The PinPoint GO WW Plus is also compatible with the **Airstream IR** app. The IR transmitter is available through any ADJ dealer or through the ADJ parts website. Plug the transmitter into the headphone jack of your iOS phone or tablet. To control your IR fixture you must raise the volume to the maximum on your iOS phone or tablet and aim the transmitter at the front of the fixture and be no more than 15 feet away. After you have purchased the Airstream IR transmitters, the app is a free download from the app store for your iOS phone or tablet. The app comes with 3 pages of control depending on the IR fixture you are using. Please see below for IR functions including the corresponding app page.

### Works with App page 1.

**STAND BY** - Pressing this button will blackout the fixture. Press the button again to return to the initial state. This button is also used to switch between normal mode and energy saving mode. When the LED flashes 3 times the unit is running in normal mode. When the LED flashes for 5 seconds the unit is running in energy saving mode. Please see Energy Saving Mode on the previous page.

**FULL ON** - Hold this button down to fully light up the unit. When you let the button go, the unit will return to its previous state.

**STROBE** - Press and hold this button for strobing.

**FADE/GOBO** - This button activates fade mode.

**“DIMMER +” and “DIMMER -”** - Use the buttons adjust the output intensity in static color mode.

**COLOR** - This button activates static color mode.

**1-9** - Use buttons 1 & 2 to select your desired fade mode.

**SOUND ON & OFF** - These buttons are invalid for this fixture.

**SHOW 0** - Press this button to activate show mode. Use buttons 1 & 2 to select your desired fade mode.

## Color Filter Install

The PinPoint GO WW Plus comes with 4 color filters and 1 frost filter. To install one of the filters carefully remove the retainer ring in front of the lens. Install the filter and replace the retainer ring. Make sure the filter cut out for the infrared receiver is in the correct place.

## Installation

The unit has two ways that it can be installed. The unit includes a X-Clip so that it can be installed on drop down ceilings. Always ensure that the unit is firmly fixed to avoid vibration and slipping while operating. Always ensure that the structure to which you are attaching the unit is secure and is able to support a weight of 10 times the unit's weight. Always use a safety cable that can hold 12 times the weight of the unit when doing this type of installation. The safety cable should go through the eye hole nut that holds the X-Clip base in place.


You can also install using the magnetic base. To do this, remove the X-Clip base by unscrewing the eye hole bolt. Once removed the fixture can be stuck to anything magnetic.

***The equipment must be installed by a professional, and it must be installed in a place where it is out of the reach of people's grasp.***
