OPERATING INSTRUCTIONS

The EUV 10 is a simple LED UV effect for clubs and mobile DJ's. The Eliminator EUV 10 is a powerful UV LED fixture capable of covering wide area spaces. With its low profile design it lends itself to be installed almost in any way imaginable. The EUV 10 is ready to be hung or set on a flat stable surface in a safe position. When mounting this unit to a truss, be sure to use a clamp. Plug the unit in to any standard wall outlet. After connecting to a power source, UV light will be emitted from the unit.

POWER CORD DAISY CHAIN

With this feature, you can connect the fixtures to one another using the input and output sockets.

The quantity that can be connected is 28 fixtures maximum. After 28 fixtures you will need to use a new power outlet. *Note: Do not mix features. The linked fixtures must be the same fixtures.*

TROUBLE SHOOTING

Light does not turn ON, flickers, or is not ON 100%.

Check if the fixture power cord is connected to a suitable power source.

Check if the power to the outlet is on and functioning.

Power OFF the fixture, and then check the connections to make sure all wires and cods are secure.

Power off the feature and disconnect the fixture from the power. Check to see if the fuse needs to be replaced.

CLEANING

Power fixture OFF and let cool for 15 minutes. Use a soft cloth to clean dust or debris from bulb and fixture. Routine cleaning is recommended every 30 days to ensure the best performance.
