LIFETIME WARRANTY LIMITED

As an expression of our confidence in the superior quality of design, material and workmanship involved in all aspects of bringing SAMICK electric guitars, electric bass guitars, acoustic guitars, banjos and mandolins (hereafter referred to as "instruments") to you, SAMICK MUSIC CORP., (hereafter referred to as SAMICK), provides the following warranty. Please read the complete text in order that you may become familiar with its terms and conditions. Should you have any questions, please contact your local authorized SAMICK Guitar Dealer.

CONDITIONS OF SAMICK LIFETIME LIMITED WARRANTY - The neck, body, and top (excluding banjo tops), are warranted as long as owned by the original buyer, and purchased from an authorized SAMICK Guitar Dealer, never to crack, split or warp.

If during the TEN (10) year period from the date of original purchase from an authorized SAMICK Guitar Dealer, any part of your SAMICK instrument (excluding electronic components) is found, upon authorized inspection, to have a defect in materials and/or workmanship, as long as, the original buyer owns it, SAMICK and/or its authorized dealer or agent will repair such defect without charge for parts or labor. If during the ONE (1) year period from the date of original purchase from an authorized SAMICK Guitar Dealer, any electronic component of your SAMICK instrument is found, upon authorized inspection, to have a defect in materials and/or workmanship, as long as you, the original buyer owns it, SAMICK and/or its dealer or agent will repair such defect without charge.

In the event SAMICK and/or its authorized agent determine any valid defect cannot be repaired to SAMICK'S specifications and satisfaction, then SAMICK will be willing to replace the defective instrument with an identical instrument, or one which is reasonably equivalent. *These warranties are not transferable to subsequent owners.

SAMICK REQUIRES PRIOR AUTHORIZATION FOR ANY REPAIRS OR REPLACEMENT UNDER WARRANTY - In the event your new SAMICK instrument is judged by SAMICK to be defective in materials and/or workmanship, your sole remedy shall be the repair or replacement as stated in this warranty.

Naturally, under no circumstances shall SAMICK be liable for any loss or damage, direct or indirect, incidental or consequential, arising out of the use of inability to use the instrument. In states that do not allow the exclusions may not apply. This warranty provides you with specific legal rights which may vary from state to state. Warranty service is limited to the contiguous United States. Such service is not available in the possessions or territories of the United States of America.

THIS IS THE ONLY WARRANTY WHICH SAMICK MAKES WITH RESPECT TO THE INSTRUMENT, AND IS IN LIEU OF ALL OTHER EXPRESS WARRANTIES, STATEMENTS OR REPRESENTATIONS MADE BY ANY OTHER PERSONS OR FIRMS ARE VOID. ANY IMPLIED WARRANTY APPLICABLE TO THE INSTRUMENTS, INCLUDING THE WARRANTY OF MERCHANTABILITY, IS LIMITED TO THE DURATIONS OF THIS EXPRESS WARRANTY. Should service under warranty be required, only an authorized SAMICK Guitar Dealer and/or its agent, is the acceptable source for service. Your authorized SAMICK Guitar Dealer will arrange for a representative to examine your instrument within a reasonable length of time. Should satisfaction not be provided by your SAMICK Guitar Dealer, we encourage you to contact the GUITAR SERVICE DEPARTMENT at SAMICK. In the event any of the provisions of this warranty are found by statute or by applicable administration or judicial entities to be unenforceable, the remaining provisions shall remain in full force.

OWNERS RESPONSIBILITIES - In order for SAMICK to provide proper warranty service, it is necessary for the buyer of any new SAMICK instrument to assume certain responsibilities:

1. Immediately after the purchase send the attached Registration Card to SAMICK, or be prepared to provide purchase and/or registration information so as to avoid undue difficulties in determining eligibility for warranty protection. Failure to return the Registration Card will not affect your rights under this warranty.
2. Immediately upon discovery of any alleged defects, notify your authorized SAMICK Guitar Dealer with a detailed explanation of the problem. If the problem has not been resolved within 60 days following notification, contact SAMICK directly. If you have moved, contact SAMICK for the name of an authorized SAMICK Guitar Dealer in your new location.
3. Permit SAMICK, or an authorized SAMICK Guitar Dealer, or an authorized agent to inspect and provide warranty service which shall be completed within a reasonable time.

PROPER USE AND MAINTENANCE - For lasting enjoyment, your new SAMICK instrument should be maintained. SAMICK'S warranty does not apply to failures or damages caused by the following:

1. Improper installation, maintenance, or repair, including tuning, neck and bridge adjustments, regulation or string replacement. (Tuning and neck and bridge adjustments are considered part of normal dealer preparation).
2. Abnormal strain, neglect, negligence, misuse, accidental damage, abuse, modifications, exposure to extremes in relative humidity (dryness/moisture), temperature or sun light, or defects due to natural aging.
3. Damages caused by an act of God, or to any SAMICK instrument on which the serial number has been altered, modified or removed from the instrument.
4. Improper maintenance, repair or service by unauthorized or unqualified persons.
5. Application of article or chemical materials to the finish and/or other components of the instrument.
6. Repair with other than genuine SAMICK parts or parts of similar quality and composition.

SAMICK does not assume or authorize any representative, or other person, to assume for SAMICK any other liability in connection with the sale or shipment of our product.

WARRANTY INFORMATION - ANY SAMICK INSTRUMENT SOLD BY AN UNAUTHORIZED SAMICK GUITAR DEALER WILL NOT BE WARRANTED BY SAMICK MUSIC CORP.

Please complete and return the attached Registration Card to SAMICK within thirty (30) days after purchase. Your rights under the warranty are valid as long as you can provide your Bill of Sale indicating the date your instrument was purchased from an authorized SAMICK Guitar Dealer.

With proper care, use and maintenance, your SAMICK instrument will give you a lifetime of musical pleasure.
