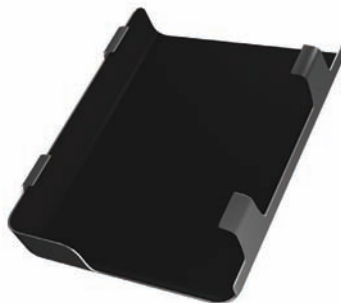
- Dial up killer amps inspired by vintage gear, and crank up the drive for a ferocious tone.

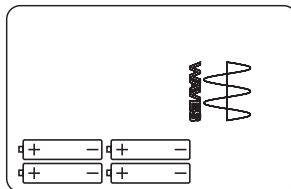

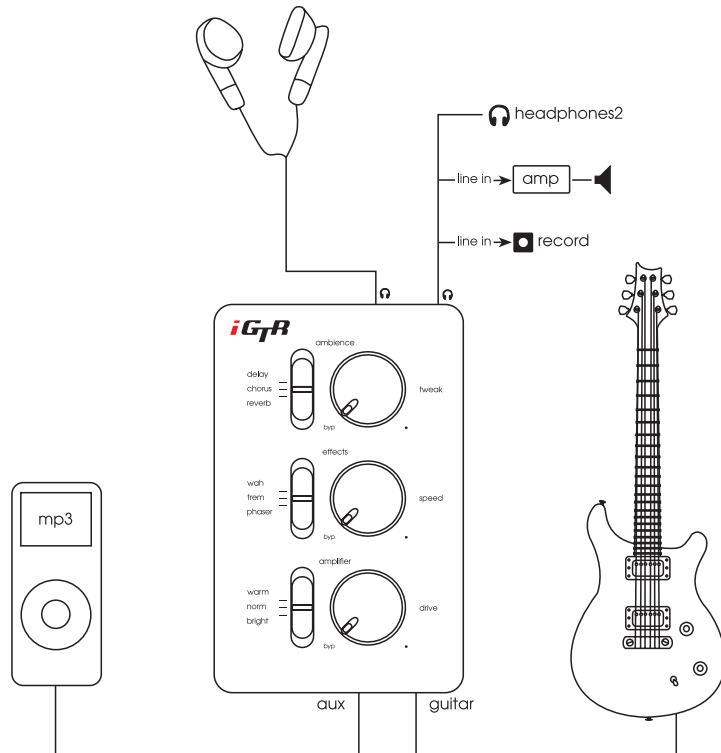
Quick Start

To begin using your iGTR, follow these simple instructions.

1. Place 4 AAA batteries in the battery compartment (as shown).
2. Connect a pair of headphones (not included) to one of the headphone jacks located at the top of the device.
3. Connect one end of your guitar cable to your guitar and the other end to the guitar input located at the bottom of the device
4. Clip iGTR to your guitar strap using the included belt clip.
5. Turn iGTR on, using the power switch located at the top of the device.
6. Place your headphones on your ears and play your guitar.
7. Use the front panel and side controls to adjust your sound.
8. Get ready to rock.



Plug & Play



Front View

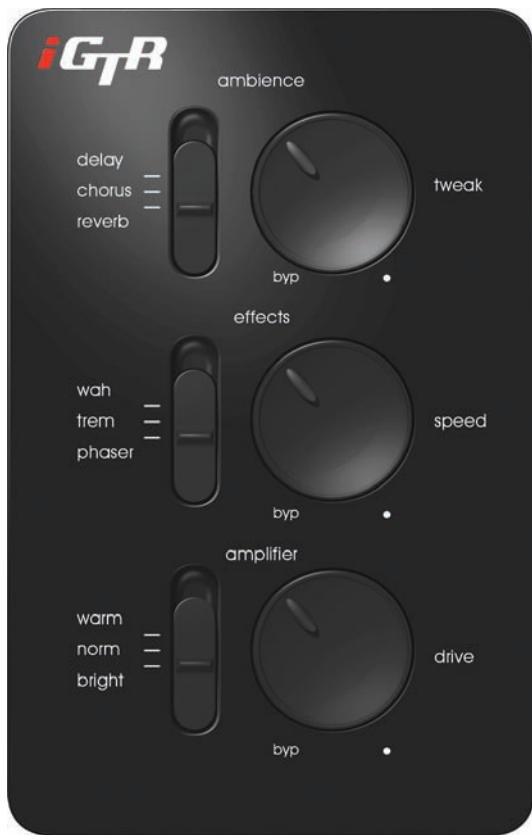
- **Ambience Effects**
 - Use the Ambience slide switch to select Reverb, Chorus or Delay.
 - Use the Tweak control to adjust Reverb or Chorus mix or Delay time.
 - BYP position: Bypass.
- **Modulation Effects**
 - Use the Effects slide switch to select Phaser, Tremolo or Wah.
 - Use the Speed control to adjust the modulation speed.
 - BYP position: Bypass.
- **Amp Simulation**
 - Use the Amplifier slide switch to select Bright, Normal or Warm amp models.
 - Use the Drive control to adjust the amount of distortion.
 - BYP position: Bypass.

Right Side View

- **Guitar** controls guitar output volume.
- **Aux** controls auxiliary volume.

Important note:

Sound quality may be impaired by low battery power.
If this happens, replace the batteries.



Top View

- Headphone jacks for 2 sets of headphones or multimedia speakers.
- On/Off switch.

*To increase battery life, turn off iGTR when not in use.



Bottom View

- 6-12Vdc is an input jack for a standard 6-12 volt DC adapter (not included).

*Important: When purchasing a DC adapter, make sure the connector, voltage, and polarity match those of the iGTR.

- Aux is an auxiliary input for a digital media (mp3) player or other playback device (cable included). Make sure the cable is plugged all the way in.
- Guitar Input for standard 1/4" instrument cable.
